The visual database table design view requires the use of a mouse or equivalent graphical input device.

Exceptions are documented above in 1194.21(c).
(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.
