Supported with exceptions:	Altova SchemaAgent 2011 supports a keyboard interface for input and provides fully customizable keyboard shortcuts for all menu items. The visual schema design view and certain schema relationship functions require the use of a mouse or equivalent graphical input device.

Supported with exceptions:	Altova SchemaAgent 2011 works with screen magnification, but some speech functionality does not work in Microsoft Narrator, Jaws, or ZoomText. Exceptions are documented above in 1194.21(c).
(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.	Supported:	Altova SchemaAgent 2011 supports the use of screen readers to access user interface information and has internal print enlarging technologies as well.
