(a) When software is designed to run on a system that has a keyboard, product functions shall be executable from a keyboard where the function itself or the result of performing a function can be discerned textually.	Supported with exceptions	Altova SchemaAgent 2014 supports a keyboard interface for input and provides fully customizable keyboard shortcuts for all menu items. The visual schema design view and certain schema relationship functions require the use of a mouse or equivalent graphical input device.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer. When an image represents a program element, the information conveyed by the image must also be available in text.	Supported with exceptions	Altova SchemaAgent 2014 represents schema relationships in a visual diagram, and some of that information cannot be represented in text.
(e) When bitmap images are used to identify controls, status indicators, or other programmatic elements, the meaning	Supported	

assigned to those images shall be consistent throughout an application's performance.		
(f) Textual information shall be provided through operating system functions for displaying text. The minimum information that shall be made available is text content, text input caret location, and text attributes.	Supported	
(g) Applications shall not override user selected contrast and color selections and other individual display attributes.	Supported	
(h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.	Supported	
(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.	Supported	
(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.	Supported	
(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.	Supported

(a) At least one mode of operation and information retrieval that does not require user vision shall be provided, or support for Assistive Technology used by people who are blind or visually impaired shall be provided.	Supported with exceptions	Altova SchemaAgent 2014 works with screen magnification, but some speech functionality does not work in Microsoft Narrator, Jaws, or ZoomText. Exceptions are documented above in 1194.21(c).
(b) At least one mode of operation and information retrieval that does not require visual acuity greater than 20/70 shall be provided in audio and enlarged print output working together or independently, or support for Assistive Technology used by people who are visually impaired shall be provided.	Supported	Altova SchemaAgent 2014 supports the use of screen readers to access user interface information and has internal print enlarging technologies as well.  Users of Windows operating systems can change the DPI settings or access Screen Magnifier in the Accessibility Options or via the Ease of Access control panel section.
(c) At least one mode of operation and information retrieval that does not require user hearing shall be provided, or support for Assistive Technology used by people who are deaf or hard of hearing shall be provided	Supported	Altova SchemaAgent 2014 does not require user hearing for access to any application functionality.
